**MINUTE ON**

**THE ELECTION RESULTS OF EMPLOYEE REPRESENTATIVES  
FOR THE PHNOM PENH WATER SUPPLY AUTHORITY, THE 9<sup>TH</sup> MANDATE**

Pursuant to Decision No. 007 រ.ប.ក., dated January 30, 2026, on the Appointment of the Election Committee for the 9<sup>th</sup> Mandate Employee Representatives of the Phnom Penh Water Supply Authority (PPWSA), and Decision No. 010 រ.ប.ក., dated February 10, 2026, regarding the Procedures for the Election of Employee Representatives as Board Members, on Thursday, February 26, 2026, the Election Committee conducted the digital election at the PPWSA headquarters. The process followed the scheduled calendar and proceeded smoothly from 8:00 AM to 1:00 PM.

As a result, out of a total of 1,306 votes, the candidates received support as follows:

1. Mr. MA NORAVIN received 637votes, equivalent to 48.77% of the valid ballots.
2. Mr. SOK NARETH received 669votes, equivalent to 51.23% of the valid ballots.

Based on the PPWSA’s Statute and Resolution No. 010 រ.ប.ក. dated February 10, 2026 on the procedure for the election of PPWSA’s employee representative, Mr. SOK NARETH, who received the support of 669votes, equivalent to 51.23% of the total votes, which is the most votes, was appointed as the PPWSA’s Employee Representative and Board Member for the 9<sup>th</sup> Mandate.

The committee were fully completed the duties on the same date, in a highly responsible manner.
